e) EDC Board – CARES Grant Application

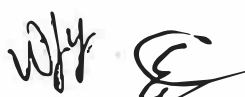
Correspondence was presented from the EDC Board in regard to a CARES Grant Application for a project to be undertaken by Economic Development in the 2018 budget.
