1. **CALL TO ORDER:** Mayor Faulkner called the Regular Council Meeting of August 19, 2013 to order at the hour of 7:00 pm.

Calmar Public Library Board member Patricia Ashley and Library Manager Kim Johnson were present to provide an update to Council on Library activities and on the YRL Plan of Service. 
