

**REGULAR MEETING OF COUNCIL OF THE TOWN OF CALMAR WAS

1. **CALL TO ORDER:** Mayor Faulkner called the Regular Council Meeting of July 18, 2011 to order at the hour of 7:00 pm.

3. **PUBLIC HEARING**

4. **DELEGATION**

- a) John Tolsma – Utility Bylaw Amendment – Rental Properties

Mr. Tolsma introduced himself to Council, and expressed concerns about the letter he received from Administration in regards to the Utility Bylaw changes, that as of January 1, 2012 landlords are responsible for the payment of their tenants utilities and that the bills will be changed into the land owners name. He felt it was a socialist intrusion and that the Town should approach the province for payment for unpaid bills, and the province should approach the federal government if the province did not have the funds.

A discussion was held in this regard, and Council explained that the Province and Federal Government would not pay for these bills. Council explained as a landowner the landowner is responsible for ensuring that Town Utilities are paid, for or by their tenant as the bylaw amendment states. They explained that this was becoming common practice in our neighbouring communities as well. Further, that for a \$5 administration fee a copy of the bill would be sent to their tenant, but it would still be the landowner's responsibility.

Mayor Faulkner thanked Mr. Tolsma for attending the meeting, and advised him that the Utility Bylaw would not be changed at this time.

- b) ISL – George Welsh – Infrastructure Upgrades

Mr. Welsh introduced himself to Council, and advised that ISL Engineering and Land Services was hired as the consultant for the upgrades to the sanitary sewer and waterlines on 49<sup>th</sup> Avenue between 47<sup>th</sup> and 49<sup>th</sup> Street and gave an overview of the problems and factors to consider on this project. This past winter the waterlines froze. Factors to consider with the lines freezing are; this has not been an issue in the past, the height of the road was higher than the sidewalk and had to be lowered 4-19" inches for proper property drainage, houses with no basements, when these types of replacements are done the frost penetration will be deeper. ISL gave the Town three options to consider to rectify the problem, 1. redoing the waterlines, 2. insulating the lines, 3. see what happens with the waterlines over the next three years with the newly installed bleeder valves. The Town of Calmar selected option 3 but asked for a warranty period of 10 years. Mr. Welsh explained that ISL was not prepared to sign a 10 year warranty at this time, and suggested that the waterlines be watched for a bit to determine the nature of the problem before signing off.

A discussion was held in regards to the cost of the extra water used for the bleeder valves, that the valves would need to be off to check for damage, that 3 years may not be enough time as weather would be uncertain, and that the Town would like to having something in writing to ensure that this problem is resolved.

Mr. Welsh explained that ISL would be paying for the extra water usage and it was still a work in progress and that he would be working with Director of Planning and Development Melesko to come to a resolution, and that the issue would continue to be monitored and that something could be provided in writing at a later time.

- e) Drama Club & CARES – Complaint from RCMP

Cindy Caudron, President of CARES made a verbal presentation on behalf of the members with concerns that they felt they were not appreciated by Town Council or staff for running the annual beer garden tent and the Calmar Fair each year due to a letter that was received from the RCMP in regards to the problems that arose and the 2010 event. Ms. Caudron explained that changes had been made for this year's event, including camping to be in the Zolner field, porta potties to be moved, hospital type wristbands to ensure no minors, any attendee caught acting out of hand would have wrist band cut and be removed from tent, no back packs, and more volunteers working the floor. The members explained that a lot of the issues that arose at the 2010 event were not actually in the beer tent that they ran but in the parking lot that they have no jurisdiction over. The group felt that the Town should have contacted them directly to discuss what could be done to resolve the issues before involving the RCMP, and assured that the RCMP's concerns had been satisfactorily addressed.

Council assured CARES and the Drama Club that they appreciate their hard work and volunteering, as does that staff and further commended them for their work and involvement in the community. Council ensured that their concerns would be brought to the staff's attention. Council thanked CARES and the Drama Club for their attendance.
