1. CALL TO ORDER: Mayor Popik called the Regular Council Meeting of February 16<sup>th</sup>, 2010 to order at the hour of 7:00pm.

#### 3. PUBLIC HEARING:

Benji Waser from Meyers Norris and Penny entered the meeting at 7:04pm.

#### 4. **DELEGATION:**

a) Erick Schmidt - Bio ReFinex

BioRefinex thermal hydrolysis process is currently the safest, validated environmental technology in the world which transforms organic wastes and residues, including specified risk materials into sterile biochemical nutrients valuable for biogas and fertilizer production. It is designed to process a wide range of residential, commercial, agricultural and industrial organic waste streams as well it provides a solution for dead stock, road kill and specialty livestock offal and high volume urban food wastes.

Biosphere4 technologies have been engaged in research and development of the BioRefinex process for over 10 years. Patents have been granted in all the major and industrial and agricultural countries of the world. A pilot test facility is maintained in Alberta and engineering of commercial plants has now commenced in cooperation with internationally experienced partners.

All testing is undertaken in government-certified labs or independent research facilities. The European Commission has approved the BioRefinex process for Category II and III animal byproduct processing and Category I (TSE'S) validation tests have been completed in Scotland.

The Canadian Food Inspection Agency has issued a "negligible" risk rating for BioRefinex processing of SRM material, with no further restrictions on the industrial use of the hydrolyzed output material.

Dr. Jianhua Zhu entered the meeting at 7:20pm.

Some of BioRefinex advantages are that it destroys infectivity of all microbial pathogens and prions, high temperature saturated steam reactors hydrolyze proteins and fats into amino acids and fatty acids, pollution free process eliminates odours and protects environment through zero waste, short cycle time, modular flexibility and small footprint, high volume sealed batch process - safety and security for human operators and regional processing and integration with municipal and industrial biogas co-generation power plants.

Discussions ensued.

Erick thanked Council for the opportunity to make a presentation to Council.

b) Meyers, Norris and Penny - Benji Waser

Benji Waser introduced himself to Council and explained the audit procedure for 2009 and informed Council that everything in the audit looked pretty good. Meyers Norris and Penny will have the final draft of the audit to Administration by March 10<sup>th</sup>, 2010 which then will be presented to Council at the next Regular Meeting of March 15<sup>th</sup>, 2010.

c) Jubilee Burgers - Melody Sommerfeld

Melody Sommerfeld introduced herself to Council and explained that she operates the concession at the Mike Karbonik Arena. Melody had previously asked if she could run a lunch program out of the Arena Concession back in November, the idea was discussed at the Nov. 2<sup>nd</sup>. Council meeting and the decision was made that she would be allowed as long as it did not become a catering service. As things were very hectic with the China Trip fast approaching Ed did not get a chance to notify her of Councils decision prior to us leaving. While in China Melody asked at the office what the decision had been, Niki e-mailed Ed to ask and he replied that she would be allowed and told her that he would give Melody a letter when he returned home. Niki however did not tell Melody of the decision thinking that Ed needed to give her the letter first. This is where the miscommunication came into play. When we returned from China Ed did not hear anything from Melody so he thought that everything was resolved. It was not until after the New Year that Ed spoke to Melody again when she asked for the reduction in rental fees. Ed once again took it to council to ask and it was decided that she could have a reduction in rent or do the lunch program not both. It was not until Ed notified Melody of councils decision that he found out that she had not been notified that she could run the lunch program, and that she had not paid the 2009 lease payment which was due on Dec. 31, 2009, and that her request for a rent reduction was not for the remaining 3 months but for the entire 6 months.

Although Melody did not get appropriate notification that she could run her lunch program back in November, under Ed's recommendation, he feels that it is not 100% the Towns fault, she could have followed up prior to January. In January when she requested the reduction in rent, the first rent payment was already past due. The Town is being more than fair by giving her the reduction in rent for January-March; however Ed does not feel that it should be for the entire season. There is a signed contract agreeing to the rent payments, and it is not the Town of Calmar's fault that business was not as expected. Ed's recommendation to Council is that council should grant the reduction in rent for the remainder of the season but feels that the first three months prior to the request for reduction should remain at the agreed upon amount of \$400.00/month.

Council thanked Melody for her comments and concerns.
