

**REGULAR MEETING OF COUNCIL OF THE TOWN OF CALMAR WAS
HELD ON MONDAY, SEPTEMBER 21, 2015 COMMENCING AT 7:00 pm
IN THE COUNCIL CHAMBERS**

1. **CALL TO ORDER:** Mayor Yachimetz called the Regular Council Meeting of September 21, 2015 to order at the hour of 7:00 pm.

PRESENT: Mayor Yachimetz, Councillors Donovan, Borodawka, Balaban, Sekora,
Town Manager Rodberg, Public and Press.

3. **PUBLIC HEARING:** None

4. **DELEGATION:**

- a) Mark Smith, MLA – Drayton Valley – Devon
Mr. Smith introduced himself to everyone and talked about his new role as the MLA. Some of the topics discussed were the Budget, educational profile and touched on the effect of the economy due to low oil prices. AB debt stands around 18-19 million.

Mr. Smith hopes to attend another Council meeting with more updates.

Mayor Yachimetz thanked Mr. Smith for his attendance.

- b) RCMP Inspector Kevin Kunezki – Public Awareness
Inspector Kevin Kunezki introduced himself to Council and the public. He spoke on several crimes, robberies, homicides in Calmar over the past few months. He stated that most of these crimes are not being committed from local residents. Kevin explained to the public that there is only so many RCMP members assigned to each jurisdiction.

Discussions ensued about Community Involvement, i.e. Citizens on Patrol. The Inspector asked the public to make sure they report all crimes, whether it's vandalism, graffiti, etc., but to make sure it's reported as this will affect the numbers on the statistical report given to Council quarterly. He informed the public that once a municipality reaches a 5000 population, then municipalities need to decide what kind of police service they want.

Questions were brought forward about the cost difference between RCMP and Community Peace Officers, CAO Rodberg stated approximately \$80,000, depending on the level of the CPO.

A show of hands for a RCMP member in Calmar vs. another CPO and most of the residents raised their hands. (Note: 41 people in attendance).

Inspector Kunezki said there will be a survey out online January 1st, 2016, so that the residents can voice their opinion as to what they want to see in their Community when it comes to policing services.

Mayor Yachimetz thanked Inspector Kunezki for his report.


