He stated that the plan would be ok if it was a condo plan where the developer is responsible for the roads, parking, etc within the condo area. Mr. Dolman feels the plan needs more work to make it acceptable.

A discussion was held between Council, the Developer and Mr. Dolman in regards to concerns addressed.
