In addition to regular council meetings, Special council meetings and various correspondence and administration duties

April 4th, 11th & 18th – Elected Officials Education Program – Attended EOEP training session for Municipal Corporate Planning and Finance. Spent 2 hours per session training on topics such as Strategy, Policy and Service Levels, Financial Planning, Monitoring and Evaluation. The course covered municipal government requirements, history of requirements, best practices adopted by a variety of communities, example reports and planning tools. Breakout sessions allowed for members of a number of communities around Alberta to work together to plan on practice scenarios and compare practices of their respective communities.

April 18th – **Leduc Regional Housing Foundation** – Attended the LRHF breakfast fundraiser which is geared to bringing community together to educate about the current housing crises in the region whether it be seniors housing options or affordable housing options for those in some for of need. Silent and live auction items along with the help of Leduc Rotary club, raised funds to be utilized for future infrastructure needs of the Foundation.

April 18th — Capital Region Southwest Water Service Commission — attended the annual general meeting, where presentations were made on the success of another year of the CRSWSC, projects completed and projects planned. Audited annual financial statements were presented and accepted by the commission. The even ended with a great risk presentation by the accounting firm risk management group related to fraud in the workplace.

April 23rd – **Calmar Library Board** – attended the library board meeting where library activities and numbers were reviewed. The director report was presented and Letter from Minister McIver announcing continued red tape reduction was also reviewed. The board was provided a copy of the Yellowhead Regional library annual report for review.

April 24rd – Committee of the Whole – Attended the committee of the whole meeting, Jeannette Adams, St. Arnaud Pinsent Steman – 2023 Financial Statements were presented to Council for the 2023 year end. Apr. 9-12/24, EDA Xperience 2024 Leaders' Summit & Conference

- First morning was a session on; What is Community Economic Development (CED)? They referred to 4 Key Elements, Process, Suitable, Balanced Growth, and Wealth. They talk about the Pillars of Community Sustainability, Environmental Protection, Economic Development and Social Development. They asked the question, why invest in economic development, and drew some linkage to the benefits. Had some discussion on where the strategic economic development plan fits in, highlighting Council Priorities/Administration Business Plan/Department Business Plans. The importance of "Vision, Mission, Priorities, Policies". Process such as SWOT (community needs assessment), Asset Inventory (turning opportunities into strategies) and Pursuing Opportunities to Overcome Barriers (Gap Analysis). All of these phrases and more are just scratching the surface and we need to pursue some council and community awareness about having a solid economic development strategy to move us forward. I know that Sandra has been working very hard in this regard, I still feel we need to do more to understand and move forward economic development (education and sharing of ideas and thoughts).
- Another session centered on "What is a pitch and why prepare one?" Having a ready to use "pitch" helps with sending a clear message and having some focus on what you are doing. How often have you been asked, "what's new in Calmar" or "how are things going in Calmar"? If we had a "pitch" that we all had on the ready, it would go a long way to tell those who are interested in us, what are we up against or generate some excitement to those who know us and those who what to know us. There are pit falls and some dos and don'ts, but we can overcome those with the right process of developing our "pitch".
- Yet another session was "Funding Economic Development, business and economic development organizations in Alberta constantly seek innovative ways to access funding and improve their products, services, and programs. These sessions usually had panelists giving their perspectives and experiences in addressing these challenges.

The highlights of his speech include: the construction of the Nisku Booster Station, praising the Administration's dedication to diligent project management and collaboration. The seamless incorporation of Leduc County East upgrades into the Maple Reinders Nisku Booster Station contract, optimizing operations and fostering a partnership with a contractor familiar with the Commission's operations and staff. Expressed gratitude to Mayor Bill Daneluik, the outgoing Chair, for his exemplary leadership and dedication to the Commission during his tenure from 2022 to 2023. Welcomed Councillor Kelly-Lynn Lewis as the incoming Vice-Chair for the 2023 to 2024 term. Extended sincere appreciation to the dedicated City of Leduc Management and Operations team for their continued hard work and commitment. Expressed confidence in the collective efforts of Commission Members and the steadfast support of the Administration team to continue achieving remarkable milestones and upholding the commitment to excellence in the face of the opportunities and challenges of 2024.
- 2023 Financial Statements and Auditors Report and Financial Discussion; Chris Cholak, Partner, MNP LLP, presented an overview of the 2023 Financial Statements and Auditors Report. Mike McCormak, CFI Investigative and Forensic Services, MNP LLP. presented on the topic of unethical conduct and fraud. These are available upon request.
- The meeting concluded with Shawn expressing gratitude to Chris and Mike for their contributions and thanking everyone for attending. He acknowledged the Board for their trust and support over the past year, attributing the organization's exceptional performance to collaborative efforts. Rick highlighted the effectiveness of teamwork during a water break incident and thanked the operators. Shawn thanked Katherine O'Dwyer for organizing the meeting and recognized Lauren Padgham for her 5 years of service, inviting Chair Hansen and Vice-Chair Lewis to present her with a token of appreciation. Chair Hansen expressed appreciation to Lauren and expressed confidence in her successor, Gerard Del Rosario.

Apr. 24/24, Leduc & District Regional Waste Management Committee

- Presentation, 2023 Draft Audited Financial Statements (Chris Cholak, Matthew Hardy, MNP). We are doing things right and the audit was good.
- Managers' Report: PDO Project, the electrical and mechanical work have been awarded with work commencing in the coming weeks. Organics Processing, in March, we received 250 MT of organics, both commercial and municipal, annually we are down slightly. Cell 5 Update, the spreading of the initial layer has been delayed. Site Activities and Security, March 2024 invoices for landfilling services were \$700 less than in 2023. Assessments on the Transfer Building floor will begin at the end of April with geotechnical investigation of the slab subsurface condition. Training for the 2024 Bird Program started on April 2. Waste Tonnage, 2024 continues to trend slightly down from 2023, with a drop of 835 MT and 529 less customers accessing the site. Site Improvements, the unattended commercial scale encountered a conflict between hardware and software which prevented it from zeroing after each transaction. Dynamic Scale were on site and have since corrected the issue. RFID cards are being tested with a small number of drivers prior to a wider rollout. Collaboration with other Regions, this collaborative group now includes representation from Leduc, Morinville, Lethbridge, Westlock, Peace River, Lac La Biche, Red Deer, Drumheller and Drayton Valley. Soil <u>Inventory</u>, Soils stockpiles will be heavily utilized over the next few months as they occupy airspace needed for waste placement. In 2024, a balance will be determined between soil needed for cover and the amounts needed for revenue. Health and Safety, no health and safety incidents occurred during this reporting period. Site Inspection, a site inspection was conducted on March 20, 2024. Goodwill, A License Agreement for a period of 5 years has been drafted and is in the final stages of approval.
- Business Arising out of the Minutes: Public Education and Communications Strategy,
 Goodwill, a media release has been prepared, and will be released to media outlets on
 April 25, 2024, Promotional Items for the LDRWMC Public Open House which is
 scheduled for June 15, 2024, will be speckled ceramic mugs. Recycled Plastic Sign,
 commission members chose a design which just happened to be the choice of
 customers and staff. Diversion Initiatives (Drywall), seeking to increase our level of
 diversion on site, the Board had instructed Administration to determine if there were
 viable offtakes for drywall in the area, after much research it was decided to not move
 forward with this at this time.

• New Business: Credit Card Borrowing Bylaw 03-2024 & Policy, Administration drafted a credit card policy for our on-site manager to help facilitate consistent and clarified rules to help with day-to-day transactions. Procedure Bylaw 04-2024, While drafting Credit Card Borrowing Bylaw No. 03-2024, Administration took the opportunity to review the Commission's existing Bylaws, Bylaw No. 01-2021 Establishment of Regional Services Commission Bylaw, and Bylaw No. 02-2022 Procedure Bylaw. Upon review, Administration noted that clause 22 of Procedure Bylaw 02-2022 does not reflect current practice, adjustments have been made. Non-profit disposal program, we will continue the existing Non-Profit Disposal Program, where member municipalities approve requests from their respective non-profit organizations and are responsible for the costs of disposal.

- Calmar's Public Library partnered with Zyp Art Gallery for a exhibition called "Sight Unseen". This exhibition was attended by Grades 3-6 for their viewing of a gallery created by a person with visual impairments. While one of the classes was at the gallery, the other was at the library listing to Amanda Thiessen who is an Ambassador for the Canadian National Institute for the Blind (CNIB).

PACT is a partnership with the RCMP, Alberta Health Services and the City of Leduc that has one RCMP officer partnered with a mental health therapist to attend calls for service with a mental health component that occur in the City of Leduc. PACT will work with the person(s) to assess their mental health and either transport them to the correct facility or direct them to resources that can help. This has been a huge success in the community and we are grateful for the City of Leduc's support.

2023 saw both Municipal and Rural calls for service increase to the highest it has been in the

last 5 years. Municipally, officers responded to 9,562 calls, which is 440 calls more than last year. Provincially, we responded to 8,133 calls, which is 192 more calls than in 2022. Statistical measures like these help the detachment Criminal

Detachment Operations

In 2023, the Leduc RCMP Detachment achieved significant milestones and, after community consultation, set goals to ensure the safety and well-being of all citizens.

Strengthening Community Engagement: Your Leduc RCMP prioritizes building strong relationships with the community. Through various initiatives such as community forums, school outreach, and our school resource officer we encourage open dialogue, trust, and collaboration between the police and residents.

Crime Prevention and Reduction: Your Leduc RCMP is continually working to implement proactive strategies to prevent and reduce crime. This past year we have focused on targeted patrols, intelligence-led policing, and strategic partnerships with other law enforcement agencies to effectively address criminal activities and ensure a safe environment for all.

Collaborative Approaches: Your Leduc RCMP actively collaborated with local government agencies, community organizations, and businesses to address social issues and create a safer community. 



Crime Statistics – City of Leduc






Crime Statistics – Leduc County (Rural)








PROS Occurrences in 2023

Percent changes from 2022 to 2023 in number of files generated:




Total Calls for Service



Detachment Support Staff

The Leduc Administrative team, currently supports the Leduc Royal Canadian Mounted Police members, and the Leduc Enforcement Community Peace Officers. In 2023 we had a long-term employee retire, five extended medical absences and two departing employees. It is always hard to operate without team members or say good bye to strong skilled employee's; but we wish them well in their recoveries and new adventures. We have welcomed some new municipal employees to our team and are very happy to see them working and blossoming through training and teamwork.

This year our Public Service team members were called upon to assist in Emergency operations centres during the 2023 Fire season and the 2023 Public Service Employee strike. These events had us focused on cross training, and prioritizing the functionality of procedures.

As was evident in the previous year, collisions are still on the rise throughout the Province of Alberta and rapidly in the Leduc area. The City of Leduc began to discuss the possibility of pairing with ASSI, an agency paid by insurance companies to gather collision information from clients. This information is then available to the Insurance provider immediately, as well as to the Leduc RCMP. The objective is to stream line the process for insurer's and insurance agencies, as well as the collision capture process for the police. This will not include those collisions that require investigation such as hit and run's, injuries or fatalities. This process is still moving through some logistical challenges and is likely to be realized in 2024. Our Administrative team will still be required to capture all collision details in the RCMP PROS database. We are optimistic that this will reduce customer interactions and thereby increase time efficiency.

In the administrative prosecution process this year we have changed our documents to meet the name changes; from the Court of Queen's Bench to the Court of Kings Bench and from the Provincial Court of Alberta to the Alberta Court of Justice. The Provincial prosecution process has been transitioning with the Justice Transformation Initiative (JTI) for the last couple of years. As a result, our administrative staff continues to transition with our prosecution process. The traffic prosecutions are now captured in the Advanced Projects Information System (APIS). Criminal matters in the E-disclosure process and the Case Management Officer process (CMO) is slowly materializing. We are preparing for the changes to the provincial prosecution "pre-charge approval process" and the Alberta Court of Justice new program JOIN 2.0 in the 2024 year. The transition of these changes has come quickly in some area's, painfully slow in others; we thank our staff who have been patient, curious and cooperative.

In 2023 we took the opportunity to cross-train some of our experienced staff in area's where they showed interest in learning new roles and expanding their knowledge. This focused on how what they do affects other areas, and what the records management obligations are in various roles. It also brought forward some changes in ideas, streamlined processes and clarified some procedures contributing to the success of our administrative support service.

We are very grateful for the additional space for staff and record keeping, that was realized with the building addition and renovations in 2022. We continue to adapt and change, creating an effective work flow in the necessary steps we take. The new space has required additional commitment to maintaining a unified service delivery. Our Records team staff created the monthly "Mountie Marvel" guide to foster communications and re-enforce the administrative processes and procedures for day to day operations. This was well received and now in 2023, has begun to include information from the court procedures as well. The "Mountie Marvel" is a way for records reviewers and court detail administration staff to link pro-actively with peers and members. It has become such a valuable tool it is now being shared with other detachment teams.



The administrative support challenges, successes and transitions are shared for your understanding of the changes; however, it does not speak to the file capture and many tasks that are done everyday. As stated, our team members work hard to meet the expectations of service delivery, the requirements for ongoing training and development, and the support given to our teammates. In 2023, we have fortunately not seen large changes in programming, equipment, or legislation. We have been able to work

on staff development, solidify procedures, train new staff and cross-train experienced staff, to meet the daily calls for service and to work forward in preparation of the future.

Leduc Enforcement Services

Working closely with the Leduc RCMP Detachment, Leduc Enforcement Services (LES) assists with the education and enforcement of City bylaws and select Provincial statutes. Some main areas of involvement from LES include traffic enforcement, property compliance, and animal control.

For 2023, LES had a total of ten officers, which included some changes throughout the year. Our total included 1 Sergeant, 2 Traffic Officers, 4 General Duty (GD) Officers, 2 Senior Officers, and 1 Community Safety Officer (CSO). The CSO was a new position for 2023 with a focus on building relationships with our unhoused population as well as various business stakeholders. The CSO worked in tandem with the City of Leduc's Family and Community



Support Services (FCSS) department to provide support and services to some of our most vulnerable population.

There was a 6% increase in occurrences in 2023 from the previous year for a total of 3,233 calls. 2,213 were dispatched calls and 527 were Officer self-generated calls; dispatch being lower from the previous year but self-generated files being higher. From the 3,052 occurrences, 1,274 were associated to a vehicle, 381 related to property (snow on sidewalk, unsightly property, noxious weeds) and 786 involved animal complaints. LES issued a combination of 3145 tickets and 3763 warnings for Provincial and Bylaw offenses.



LES was involved in various community events including; Black Gold Rodeo, Canada Day activities, McHappy Day, Tim Hortons Camp Day, Linsford Community BBQ, Summer in the City, Skatepark Slam, Southfork Dog Parade, No Stone Left Alone Remembrance Day, Santa Clause Parade, and Stuff a Cruiser.

2023 was the second year that LES, along with RCMP, participated in Project REV'N. Following the success of

2022, this initiative focuses on targeting loud and disruptive vehicles within Leduc that can negatively affect the quality of life for our residents.

Leduc Drugs / GIS

General Investigation Section (GIS)

The Leduc General Investigation Section (GIS) consists of four experienced members (three Constables and one Corporal) who work in plain clothes capacity and have received specialized training.

In 2023, Leduc GIS investigated a variety of crimes such as arsons, home invasions, possession of explosives for a dangerous purpose, possession of child pornography, weapons trafficking/3D gun printing, international missing persons, aggravated assaults, suspicious deaths, etc. Last year, Leduc GIS investigated and assisted with approximately 123 serious files. Throughout 2023, Leduc GIS investigated a sudden death of a child, which resulted in Crown Prosecutor approval for manslaughter charges and the file is now before the Courts.

Leduc GIS are also mandated to support General Duty members allowing them to spend more time responding to calls for service in the community. Leduc GIS members have the experience to assist and mentor junior members with reviewing judicial authorizations (such as search warrants), interviewing suspects, witnesses and vulnerable victims. Leduc GIS often work in collaboration with other specialized units like the Major Crime Unit (MCU), Historical Homicide Unit (HHU) and Alberta Law Enforcement Response Team (ALERT). Due to their advanced skill set, Leduc GIS, are regularly sought after by district teams and surrounding Detachments to assist in various sensitive investigations.

Drug Section

The Leduc Drug Section is currently operating at half capacity, with 2 Constables. The unit concluded 9 projects focusing in the possession and resale of illicit drugs within the community, which resulted in 44 drug trafficking charges being laid on a total of 8 suspects. The drug unit seize approximately 337 grams of cocaine, 76 grams of meth, \$4000 cash and seized 5 firearms. A total of 22 Judicial Authorizations were executed which included; Search Warrants, Tracking Warrants, Transmission Data Recorder Warrants and Production Orders.

The Drug Section worked with several policing partners including the Leduc RCMP Crime Reduction Unit and General Investigations Section, the ALERT Drug Undercover Street Team, the Wetaskiwin RCMP Crime Reduction Unit and General Investigations Section and Parkland RCMP Drug Section.

Operations Support

Crime Reduction Unit



The Leduc Crime Reduction (CRU) consists of three experienced constables, whom work in both uniform and plain clothes capacity depending on the needs of investigations and crime trends in the community.

The unit's primary purpose is to catch Prolific Offenders that contribute a disproportionately high amount of crime statistics. In 2023, Leduc CRU has completed a total of 10 Prolific Offender bail packages. These bail packages have assisted with the judicial

processing on these habitual offenders, reducing the criminal activity within the community.

Over the year the unit conducted numerous projects, these projects afforded the unit to lay over 60 charges. CRU this year has recovered well over \$200,000 in stolen property.



CRU conducted 2 warrant round ups in 2023 where numerous arrests were affected and warrants executed. The unit

also conducted bait projects, these were deployed to reduce thefts and assist the unit in identifying offenders. The bait deployments resulted in the unit laying over 14 Criminal Code charges.

The Crime Reduction Unit worked with several policing partners including Leduc General Duty, Drugs and General Investigations Section, the RCMP Emergency Response Team, Police Dog Services, Wetaskiwin Crime Reduction Unit, Central Alberta District Crime Reduction Unit and Edmonton Police Services.

School Resource Officer

Leduc RCMP's partnership with the Black Gold School Division and St. Thomas Aquinas Roman (STAR) Catholic School Division continues to grow with RCMP working to build constructive, positive relationships with students and staff while maintaining a safe school environment.



Cst. Muz completed his 7th year as the School Resource Office (SRO) in June of 2023. For his fifth time, Cst. Muz showed off his fun approachable side when he competed in another Lip Sync battle with students and staff participation.

In the beginning of the 2023/2024 school year, Cst. Cline began working as Leduc's SRO and has been connecting

with students and staff to continue building healthy and trusting relationships.

Leduc RCMP members continue to support the school community by attending assemblies, presenting on various topics including the role of SRO, smart choices, online safety, drug use, consent and many more. They also assist with investigations involving school aged youth and any Violent Threat Risk Assessments (VTRA). Leduc RCMP detachment's "School Action for Emergencies" (SAFE) plans continued to be reviewed and updated as needed.

In addition to the designated SRO for City of Leduc schools, members of Leduc RCMP have taken on additional shifts to support all schools in the Leduc detachment area including home school students with education, awareness and opportunities to connect with their local police.

Leduc Police and Crisis Team

In 2023 the Leduc Police and Crisis Team (LPACT) commenced. The LPACT team is a community-based mobile response team comprised of a Leduc RCMP officer and a Registered Psychologist from Alberta Health Services, who respond together to calls for service with a mental health nexus in the City of Leduc. The combination of law enforcement resources paired with mental health expertise ensures that an appropriate response is delivered, while ensuring public safety. This collaborative approach with an individual specific, wrap-around resolution is created to assist these individuals in receiving appropriate support with a goal of reducing RCMP calls for service.

LPACT supports members with on-scene risk assessment of individuals during a mental health crisis. Referrals are made to appropriate healthcare and community resources including Access 24/7 and Family Community Support Services (FCSS) for the individual and/or their families. Additionally, LPACT provides short-term follow-up with clients when needed and liaising with community agencies providing mental health counselling. The team endeavours to foster strong relationships with our community partners.

Scheduling for the LPACT hours of operation are based on a number of factors including the analysis of current emergency call data and will be monitored to ensure needs are met.

Through a coordinated response to mental health situations in the community, LPACT is expected to provide timely interventions and reduce the burden on the healthcare system. The team is committed to providing appropriate mental health supports that will enhance the health, safety and community wellbeing throughout the City of Leduc.

Strategic Communications

Strong relationships of mutual trust between police and the communities they serve are critical to maintaining public safety and effective policing. Much of this is done through communication both internally and externally. The use of the media to inform the public of police activities, crime prevention initiatives and events is important because our Detachment can improve support and public perception by obtaining assistance from the public on investigations, thereby demonstrating the value of service provided by the Leduc RCMP in Alberta.

Information sharing is a fundamental piece to any partnership. Our goal is to ensure positive relationships with our partners and to enhance community confidence and engagement. Depending on the nature of the information shared, we use various communication platforms including media releases, social media, in-person presentations and RAVE. RAVE is a mass notification system that gives the Alberta RCMP the ability to fanout real-time information and alerts to the community. The Leduc RCMP encourages all Albertans to sign up for the RAVE system at: https://www.getrave.ca/smart911/ref/login.action?pa=CrimeWatchAdvisoryAB.

Our Public Information Officer, Constable Cheri-Lee Smith is the official spokesperson for the Leduc RCMP Detachment and acts as a primary liaison between Detachment, media and our partners. Leduc RCMP provides information via media release on emergency incidents. The information is released through direct notification to the media agencies and through RAVE. The immediate release of information will be dependent on public, victims and officer safety concerns as well as integrity of the investigations. Media releases are also done when Leduc RCMP are seeking the public's assistance to identify suspects, locate missing persons or to promote public participation in crime prevention initiatives and Leduc RCMP community events. This is of great value in the ongoing and evolving relationship between Leduc RCMP and the communities we serve. Leduc RCMP also shares information through social media via our Alberta RCMP social media accounts and partners with the City of Leduc, Leduc County and the Town of Calmar. Information in relation to Leduc Detachment areas crime statistics can also be found on the free Alberta RCMP app.
