TOWN OF CALMAR NOTICE OF PUBLIC HEARING – BYLAW 2024-06 AT THE TOWN OFFICE – COUNCIL CHAMBER (4901-50 Ave) AND VIRTUALLY AS A GO TO MEETING PUBLIC ACCESS CODE: 211-016-493

Pursuant to Section 606 of the Municipal Government Act, Chapter M-26, RSA 2000, and amendments thereto, notice is hereby given advising of a Public Hearing to be held at **the Town's Office and Virtually** on **Tuesday, September 3rd, 2024 commencing at 6:30 pm** or as soon as possible thereafter.

The purpose of the hearing is to provide the public with the opportunity to comment **on proposed Bylaw No. 2024-06**, being a bylaw to amend the Land Use Bylaw.

Bylaw No.2024-06 proposes to create a Direct Control District for Lot 10, Block 1, Plan 122 1895 which is located at 5223 – 50 Avenue. The subject site and its location are shown on Schedule A that follows.

The proposed Direct Control District sets out specific regulations for the subject site relating to the development of a five (5) storey, 40 dwelling unit apartment building. The property was subject to a redistricting in 2022 for an apartment building with 35 units. The new proposal is to increase the number of units to 40 units.

Under the proposed Direct Control District, decisions on development permit applications for the subject site would be made by Town Council.
