#### **BACKGROUND/PROPOSAL:**

Section 606 of the MGA states that Council must give notices of certain bylaws, resolutions, meetings, public hearings, or other things by advertising in a newspaper or other publication circulating in the area. In addition, Section 606(1) allows Council to adopt a bylaw for alternative means of advertising these items, which may include electronic means.

At the July 29, 2024 Special Council Meeting, Administration introduced Bylaw #2024-06 and it received first reading.

The proposed bylaw main purpose is to increase from 35 to 40 the number of dwelling units. This property was already redistricted to Direct Control in 2022.

Proposed Bylaw #2024-06, a bylaw amending the Land Use Bylaw is attached for reference.

#### DISCUSSION/OPTIONS/BENEFITS/DISADVANTAGES:

The public hearing was advertised on the Town's website, at the Town's Office, and on the digital sign. A referral to agencies was also conducted and the Town has received a few responses stating no concerns. The summary of response is attached to the report. Administration did not receive any written submission or request to be registered for the public hearing at the time of preparing the report.

Once Council will have heard the comments from the public hearing, there will be a few options.

<u>Option 1</u> – Council may request further information from Administration prior to proceeding with second reading of Bylaw #2024-06.



<u>Option 2</u> – Council may provide direction to Administration on changes to Bylaw #2024-06 before contemplating second reading.

Option 3 - Council may pass second reading of Bylaw #2024-06.

Option 4 - Council may pass second and third reading of Bylaw #2024-06.

Option 5 - Council may defeat Bylaw #2024-06.

Administration believes that there are no benefits in choosing option 5 unless the increase in density of units is a major preoccupation.

### **COSTS/SOURCE OF FUNDING (if applicable)**

There is no cost to the municipality.

That Council gives second and third reading to Bylaw #2024-06, provided that there are no additional items requiring investigation.
